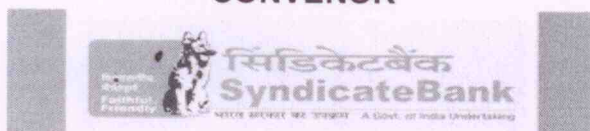

Subject: Implementation of Pradhan Mantri Fasal Bima Yojna (PMFBY) and Weather Based Crop Insurance Scheme (WBCIS) in Cluster 1 and Cluster 2 of Karnataka during Kharif'2016

Dear Sir/Madam,

Greetings from Universal Sampo General Insurance!!!
We are pleased to inform that we have been authorized to implement PMFBY and WBCIS scheme in Cluster 1 and Cluster 2 of Karnataka for Kharif'2016 with work order issued by State Government of Karnataka, Department of Agriculture, vide no. "DDA (CI)/TO-I/PMFBY/IP/2016-17"

The important points of notification, provision of the scheme & guidelines are as under:

- **Districts Allotted:** 20 Districts as per Annexure-1
- **Farmers to be covered:** All farmers including share croppers, tenant farmers growing notified crops as per districts mentioned in annexure 1 are eligible to insure the crops under PMFBY and WBCIS scheme.
 - **On Compulsory basis:** Loanee farmers are to be compulsorily covered under PMFBY/WBCIS scheme. All Farmers availing Seasonal Agricultural Operations (SAO) loans from Financial Institutions (i.e., loanee farmers) for the crop(s) notified in Kharif'2016 would be covered compulsorily.
 - **On Voluntary Basis:** All other Farmers except for Loanee Farmers i.e. **Non-loanee farmer** growing notified crops in notified area this season can opt for the scheme and submit duly filled-in **Declaration form with requisite land record documents i.e. Land Possession Certificate(LPC), ID proofs, Address proofs and copy of Bank passbook**, applicable contract/agreement details(in case of share croppers/tenant farmers) & premium at the local bank branch where he/she has bank account or to the Insurance company representative.

- Coverage of Risks

Following stages of the crop and risks leading to crop loss are covered under the scheme.

- Prevented Sowing/ Planting Risk**-Insured area is prevented from sowing / planting due to deficit rainfall or adverse seasonal conditions. Cutoff date for declaration of prevented sowing by District Deputy Commissioner will be 15-7-2016.
- Standing Crop (Sowing to Harvesting)** – Comprehensive risk insurance is provided to cover yield losses due to non-preventable risks viz.Drought, dryspells, flood, inundation, pests and diseases, landslides, natural fire and lightning, storm, hailstorm, cyclone, typhoon, tempest, hurricane and tornado.
- Post - Harvest Losses**-Coverage is available only upto a maximum period of two weeks from the harvesting for those crops which are allowed to dry in cut and spread condition in the field after harvesting against specific peril of cyclone, cycloneic rains and unseasonal rains.
- Localized Calamities** - Loss/damage resulting from occurrence of identified localized risks of hailstorm, landslide and inundation affecting isolated farms in the notified area.
